Canvass of Local Election Returns

An adjourned meeting of the Common Council for the City of North Mankato was held in the Council Chambers of the Municipal Building on Thursday, November 4, 1982, for the purpose of canvassing the returns from the regular municipal election held on Tuesday, November 2, 1982. Councilman Comstock called the meeting to order at 5:30 p.m.

The following were present: Councilmembers Comstock, Waldron, and Wilker. Staff members present were Administrator Ringhofer and Clerk Greenfield. Councilman Saye and Mayor Dehen were unable to attend.
