

AN ORDINANCE REPEALING ORDINANCE 67, 2d RELATING TO
THE ANNEXATION OF LOT 5, WEBBER'S SUBDIVISION

WHEREAS, Ordinance 67, 2d annexing Lot 5, Webber's Subdivision was enacted on June 14, 1982; and

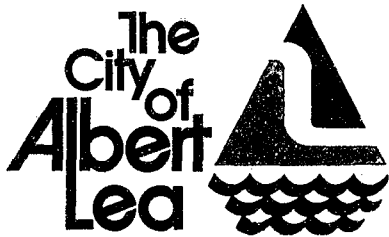
