

ORDINANCE NO. 82-6

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF LINDSTROM TO INCLUDE CERTAIN UNINCORPORATED TERRITORY BORDERED BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON.

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, or borough; and

WHEREAS, 60% or more of the perimeter of this territory is bordered by lands already included within the corporate limits of the city and is deemed to be urban or suburban in character;

The city council of Lindstrom ordains:

Section 1. Territory annexed. The corporate limits of the city of Lindstrom, Minnesota are hereby extended to include the platted and unplatted territory described as follows, 60% or more of the perimeter of which territory is bordered by territory already included within the city limits:

That part of Lots 6, 7 and 8 of Block 1 of the recorded plat of Andrews Beach, Chisago County, Minnesota, lying easterly of Irene Avenue and lying south of the North 80 feet thereof.

AND

That part of Lots 7 and 8, Block 4, Lots 1 and 2, Block 5 and Lake Avenue all of the recorded plat of Andrews Beach, Chisago County, Minnesota, described as follows:

Commencing at the northwesterly corner of said Lot 2, Block 5; thence southerly, along the westerly line of said Lot 2, a distance of 250 feet to the northerly line of the railroad right of way (now abandoned) and a point hereinafter known as "Point A"; thence easterly, parallel with the north line of said Lot 2, to the shore line of North Center Lake and the point of beginning of the parcel to be described; thence westerly, retracing the last described line, to said "Point A"; thence northwesterly, along said northerly railroad right of way to the westerly line of the easterly 50 feet of said Lot 1, Block 5; thence northerly, along said westerly line to the southerly line of Lake Avenue; thence northerly to a point on the southerly line of said Lot 7, Block 4, distant 80 feet easterly of the southwest corner thereof; thence northerly, parallel with the east line of said Lot 7, a distance of 200 feet; thence westerly, parallel with the southerly line of said Lot 7, to the west line of said Lot 7; thence northerly, along said west line to the shore line of North Center Lake; thence southeasterly, along said shore line to the point of beginning.



Section 2. Zoning. The said area is hereby zoned R1.

Section 3. Filing. The city clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the county in which the property is located, the Town Clerk of the affected township and the Minnesota Municipal Board.

Section 4. Effective date of annexation. This ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 3 and approval by the Minnesota Municipal Board.
