AN ORDINANCE ANNEXING PROPERTY
TO THE CORPORATE LIMITS

WHEREAS, certain property described below is not presently included in the corporate limits of any incorporated city, village, or borough; and

WHEREAS, the owner of the property described below has petitioned the City of Mankato for annexation of such property; and

WHEREAS, the property is located adjacent to existing city boundaries and can be served with public utilities; and

WHEREAS, the Council of the City of Mankato finds that the property is about to become urban in character and no objections to the annexation have been received;

NOW, THEREFORE, the City of Mankato hereby ordains that the corporate limits of the City are hereby extended to include the land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been part thereof:

That part of the Southeast Quarter of the Southeast Quarter of Section 19, Township 108 North, Range 26 West, Blue Earth County, Minnesota, described as:


Commencing at the Southeast corner of Section 19; thence North 00 degrees, 00 minutes, 00 seconds East (assumed bearing) along the East line of the Southeast Quarter of Section 19, a distance of 557 feet to the point of beginning; thence continuing North 00 degrees, 00 minutes, 00 seconds East, along said East line, the same being the center line of Monks Avenue, a distance of 140 feet; thence South 90 degrees, 00 minutes, 00 seconds West, 210 feet; thence South 00 degrees, 00 minutes, 00 seconds West, and parallel with the East line of the Southeast corner of Section 19, a distance of 140 feet; thence North 90 degrees, 00 minutes, 00 seconds East, 210 feet to the point of beginning. Said tract containing .67 acres, subject to any and all easements of record.


This City Clerk is hereby directed to file copies of this ordinance with the Minnesota Municipal Board, the Secretary of State, the Blue Earth County Auditor, and the Mankato Town Board.

This ordinance shall take effect 30 days after its passage, due publication thereof and approval by the Minnesota Municipal Board.
