Dear Secretary Grove:

Enclosed please find (1) a Resolution of the District Court Judges to merge with the County Court and (2) a Resolution of the County Court Judges to merge with the District Court. These two Resolutions are sent to you to certify to the Secretary of State of intention to reorganize the trial courts by a majority of the District Judges and a majority of the County Judges of the Tenth Judicial District pursuant to Minnesota Statutes 487.191.

It is my understanding that effective January 10, 1984, there shall be one general trial court in the Tenth Judicial District known as the District Court, which shall also be a Probate Court.

If anything further is needed so that we are in total compliance with 1982 Laws, Chapter 398, Section 8, please advise.
