#### MINNESOTA ANNUAL REPORT BY FOREIGN CORPORATION

#### Who Must File

Every foreign corporation authorized to do business in the state of Minnesota.

#### **New Companies**

A corporation qualified in Minnesota after January 1 of the current year is not required to file this report until between January 1 and April 1 of the next year.

#### Report Due

Between January 1 and April 1 each year, covering the previous calendar year.

#### Returns To Be Signed By

The president or vice president and the treasurer or assistant treasurer or the secretary or assistant secretary of the corporation.

#### Forms

Forms are furnished by the Secretary of State. The Secretary of State furnishes an annual report form with the receipts returned on time of qualification, and thereafter encloses with the receipt for payment of the fee for filing the current annual report a blank copy of the form for use in the following year. If additional forms are needed, the Secretary of State's office should be contacted at the address indicated below or call (612) 296-9214 or (612) 296-8981.

### Computation Of Fees

Example: A corporation reporting \$803,000 in Minnesota taxable net income for the taxable year ending October 15, 1981, enters \$803,000 in line 1. The number in line 2 is  $$803,000 \div 100000 = 8.03$ . Line  $3 = 8 \times $15 = $120$ . The number to the left of the decimal in line 2 is .03, so we add \$15, for a total of \$135. The amount \$135 is entered on line 7, because \$135 is greater than \$30. Line 9 equals the \$135 license fee plus the \$20 filing fee, or \$155.

Example: A corporation reporting \$55,000 in taxable net income would enter .55 in line 2, 0 in line 3, \$15.00 in line 4, and line 5, \$30 in line 7, because line 6 is greater than line 5, and \$50 in line 9.

Example: A corporation reporting a loss of \$15,000 would pay the minimum \$30 fee, plus the \$20 filing fee.
