AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF ALBERT LEA TO INCLUDE CERTAIN UNINCORPORATED TERRITORY COMPLETELY SURROUNDED BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON (TRUNK HIGHWAY NO. 13)

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, or borough; and

WHEREAS, this territory is completely surrounded on all sides by lands already included within the corporate limits of the City and is deemed to be urban or suburban in character; now, therefore,

THE CITY OF ALBERT LEA ORDAINS:

Sec. 1. Territory Annexed. The corporate limits of the City of Albert Lea, Minnesota; are hereby extended to include the unplatted territory described as follows, which territory now is and has heretofore been completely surrounded by territory already included within the city limits:

Beginning at SE cor Lot 1, Block 1, Harms Addition to the City of Albert Lea, Minnesota; thence N 68^o53'34", E 275' to the east rightof-way line of State Highway No. 13; th N along the east right-of-way line of State Highway No. 13 to a point of intersection of an extension of the north line of Lot 1, Block 1, Imperial Addition and said east right-of-way line; thence west across State Highway No. 13 on an extension of said north line of Lot 1, Block 1, Imperial Addition, to the northeast corner of Lot 1, Block 1, Imperial Addition; thence southeasterly on the west right-of-way line of State Highway No. 13 as follows:

Southeasterly 14.60'; Southeasterly 720.89';

Southeasterly 97.06' to the east-west centerline of Section 6 - T102N - R21W; thence east 118.13' to the center of said Section 6; thence south 100' on the north-south centerline of said Section 6 to the south line of Freeborn County Road No. 74; thence east 57.18' on the south line of Freeborn County Road No. 74 to the west right-of-way line of State Highway No. 13; thence southeasterly on the west right-of-way line of State Highway No. 13 as follows:




