The property description in Findings of Fact XXXIII on page 6 of the Municipal Board Order dated February 17, 1983, is hereby amended as follows:

That portion of Parcel A described as follows: All of the N $\frac{1}{2}$ of Sections 4 and 5, Township 132N, Range 43W lying north of south edge of Ottertail River Flowage not already within corporate limits.

Parcel C

That part of Section Two (2), Township One Hundred Thirty-two (132) North, Range Forty-three (43) West, described as follows: All of the Southeast Quarter of the Southwest Quarter (SE $\frac{1}{4}$ of SW $\frac{1}{4}$) except that part presently within the Corporate Limits of the City of Fergus Falls; and all of the Southeast Quarter (SE $\frac{1}{4}$) lying North of the South right of way line of T.H. 210 and West of the East right of way line of the Burlington-Northern Railroad, except that part presently within the Corporate Limits of the City of Fergus Falls; and that part of the Southwest Quarter of the Northeast Quarter (SE $\frac{1}{4}$ SW $\frac{1}{4}$ of NE $\frac{1}{4}$) lying West of the East right of way line of the Burlington-Northern Railroad; except that part presently within the Corporate Limits of the City of Fergus Falls.
