ORDINANCE NO. 82-2

AN ORDINANCE ANNEXING CERTAIN LANDS OWNED BY THE CITY OF ATWATER
AND EXTENDING THE CORPORATE LIMITS OF THE CITY OF ATWATER

The City Council of the City of Atwater does ordain as follows:

SECTION 1. Origination and Procedure. The City of Atwater owns all of the lands being annexed by this Ordinance, and pursuant to §414.033, Subd. 2, of Minnesota Statutes, such lands are deemed to be urban or suburban in character or about to become so. True and correct copies of this Ordinance shall be filed with the Minnesota Municipal Board, the Genessee Township Board, the Kandiyohi County Auditor, and the Minnesota Secretary of State.

SECTION 2. Description. The lands subject to this annexation are in the Township of Genessee, County of Kandiyohi, State of Minnesota, described as follows, to-wit:

Block 66, of the First Addition to Atwater as of public record, Kandiyohi County, Minnesota, and that part of the NW 1/4 of the SE 1/4 of Section 11, Township 119, Range 33, lying Northwesterly of the centerline of the Township Road; AND


That part of the SW 1/4 of the NE 1/4 and the SE 1/4 of of the NW 1/4 and the NE 1/4 of the SW 1/4 of Section 11, Township 119, Range 33, described as follows: Beginning at the Southeast corner of said NE 1/4 of the SW 1/4; thence on an assumed bearing of S 88°53'10" W, along the South line of said NE 1/4 of the SW 1/4, a distance of 1320.63 feet to the West line of said NE 1/4 of the SW 1/4; thence on a bearing of N 0°11'06" W, along last said West line 400.00 feet; thence on a bearing of N 61°23'49" E, 510.26 feet; thence on a bearing of N 20°21' E, 829.46 feet; thence on a bearing of North, 482.52 feet to its intersection with the Westerly extension of the North line of the Park as platted in said First Addition to Atwater; thence on a bearing of N 85°02'58" E, along last said line to the West line of Eighth Street as platted in said First Addition to Atwater; thence Southerly along last said West line to the North Shore of Upper Lake; thence Westerly, Southerly and Easterly along said Shore to the East line of said NE 1/4 of the SW 1/4; thence South along last said East line to the point of beginning. Except the South 200.00 feet of the East 411.00 feet of said NE 1/4 of the SW 1/4.

SECTION 3. Annexation. The City Council hereby determines (1) that the annexation will be in the best interests of the City and the

territory affected; (2) that the territory described herein abuts upon the city limits and is about to become urban or suburban in character; and (3) that none of said territory is included within the limits of any city or borough. Therefore, the area proposed for annexation is hereby annexed to and included within the city limits as effectually as if it had originally been a part thereof.


