Councilman Kastner introduced the following resolution and moved for its adoption:

RESOLUTION # 83-12

An Ordinance Extending the Corporate Limits of the  
City of Grand Rapids to Include Certain Unincorporated Property  
Abutting Upon the City Limits

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village or borough; and

WHEREAS, this territory is surrounded on two sides by lands already included within the corporate limits of the city, and

WHEREAS, Itasca County and Grand Rapids Township has notified the City that they have no objections to this annexation, and

WHEREAS, a public hearing was duly held by the governing body of the City of Grand Rapids on the proposed annexation.

The City Council of the City of Grand Rapids ordains:

Section 1. Territory Annexed. The corporate limits of the City of Grand Rapids, Minnesota are hereby extended to include the unplatted territory as follows:

That part of Southeast quarter of Southwest quarter (SE $\frac{1}{4}$ -SW $\frac{1}{4}$ ), Section Twenty-eight (28), Township Fifty-five (55), Range Twenty-five (25), described as follows: Commencing at a point 50 feet East and 33 feet South of the Northwest corner; thence South and parallel to the West line 184.8 feet; thence East parallel to the North line 155.84 feet; thence South parallel to West line 92.4 feet; thence East parallel to North line 155.84 feet; thence North parallel to West line 277.2 feet; thence West 311.68 feet to point of beginning.

Section 2. Filing. The City Clerk is directed to file certified copies of this ordinance with the Secretary of State, The County Auditor of Itasca County, Grand Rapids Township Board, and the Minnesota Municipal Commission.

Section 3. Effective Date of Annexation. This ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 2.


Councilman Akre seconded the foregoing resolution and upon roll call, the following voted in favor thereof: Pollard, Huntley, Akre, Kastner, Sackett; and the following voted against same: None, whereby the resolution was declared duly passed and adopted.
