

TOWN OF BASS BROOK

RESOLUTION NO. 120-83-4

PERTAINING TO THE ADOPTION OF URBAN TOWN POWERS UNDER MINNESOTA STATUTES 368.01 SUBDV. 1 AND OTHER RELATED STATUTES.

WHEREAS, the Minnesota State Legislature has passed legislation under Minnesota Statutes Chapter 368 and other related statutes which enable certain towns to exercise certain powers there-in listed, and

WHEREAS, such powers give to the Towns the authority to deal with problems associated with Urban Towns, and

WHEREAS, the Town of Bass Brook now has problems associated with its development into an Urban Town and needs these powers to resolve its problems, and

WHEREAS, the electors at the March 8, 1983 Annual Town Meeting held in the Town of Bass Brook voted in favor of adopting Urban Town Powers under Minnesota Statutes Chapter 368.01 Subdv. 1A and other related statutes, and,

WHEREAS, it has been determined by the Bass Brook Town Board of Supervisors that there are twelve hundred (1200) people residing in platted areas of the Township based on the following information:

TOTAL POPULATION - 1980 CENSUS = 1856

PLATS WITHIN THE TOWNSHIP:

Former City of Cohasset (platted) 185 homes + 4 Apt.)
Skelly's Portage - 121 Homes
Pokegama Acres - 19 homes - 76 people
Evergreen Addition - 5 homes
Burr Oak Plat - 7 homes
Hutchins Addition - 5 homes
Johnson Addition - 5 homes
Bass Brook Acres - 4 homes
Bieir Addition - New - 2 homes
Indian Point Addition - 10 homes

Information received from the Itasca County Auditor which indicates that there are a total of 488 homestead sites in the township of which 358 are within the platted areas listed.

And estimating 3.5 persons per home living in unplatted areas, indications are that there are approximately 1401 people residing in platted areas of the Township.

NOW, THEREFORE, BE IT RESOLVED, that effective March 9, 1983, the Town of Bass Brook is now declared an Urban Town with all the powers given under Minnesota Statutes Chapter 368.01 Subdv. 1 and other related statutes and the Auditor of Itasca County and the Secretary of State of the State of Minnesota be so notified.


We are enclosing our Resolution No. 120-83-4 adopted on March 9, 1983 by the Bass Brook Town Board of Supervisors pertaining to the adoption of Urban Town Powers under Minnesota Statutes 368.01 Sub. 1 and Other Related Statutes.

At the Annual Town Meeting March 8, 1983, voters in the Township elected to adopt Urban Town Powers under Minnesota Statutes 368.01, Subd. 1A. Certification of the results of this special ballot vote was sent to you on March 10, 1983.

In view of both these actions, the Town of Bass Brook now qualifies as an Urban Township under both M.S. 368.01 Subdv. 1 and M.S. 368.01 Subd. 1A.
