AN ORDINANCE OF THE CITY OF PIPESTONE AMENDING ORDINANCE 1.37; "AN ORDINANCE ANNEXING CONTIGUOUS TERRITORY TO THE CITY OF PIPESTONE" BY CHANGING SECTION 1.


THE CITY OF PIPESTONE ORDAINS:

Section 1. Section 1 of Ordinance 1.37 is hereby amended to read as follows:

"A tract of land described by metes and bounds as follows: Commencing 80 rods east of the Northwest corner of W  $\frac{1}{2}$  of NW  $\frac{1}{4}$ , 18-106-45, thence running east 198 feet, thence south 631.3 feet; thence west 198 feet, thence north 631.3 feet to the point of beginning, containing 2.86 acres; now owned by the Southwestern Minnesota Cooperative Electric, and being contiguous to and abutting on the incorporated limits of said city, is hereby declared to be a part of the City of Pipestone."

Section 2. This ordinance shall take effect and be in full force from and after its passage and publication.
