## ORDINANCE # 20

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF CONGER TO INCLUDE CERTAIN UNINCORPORATED LAND WHICH IS UNPLATTED LAND, NOT EXCEEDING 200 ACRES IN AREA, ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain Petition was submitted to the Council of the City of Conger, on the  $5^{0}$  day of  $\mathcal{May}$ , 19S/, requesting annexation of the territory hereinafter described, and said Petition was duly presented to the Council and accepted by the Council; and

WHEREAS, the quantity of land embraced within the area described in the Petition and bounded as described is 0.383 acres of unplatted land, no part of which is included within the limits of an incorporated City, Village, or Borough; and

WHEREAS, the Petition was signed by all the owners of the unplatted property requesting annexation; and

WHEREAS, no objections to the annexation have been received from the Town Board, the County Board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the Petition abuts upon the City limits at the northwestern boundary thereof;

THE COUNCIL OF THE CITY OF CONGER, MINNESOTA, ORDAINS:

#### SECTION 1:

The City Council hereby determines that the annexation will be in the best interests of the City and of the territory affected, that the territory described herein abuts upon the City limits and is or has become urban or suburban in character; and that none of said territory is now included within the limits of any City, Village, or Borough.

## SECTION 2:

Territory Annexed. The corporate limits of the City are hereby extended to include the unplatted land described as follows in Exhibit 1, which is made a part of this Ordinance the same as if set forth fully herein, and the same is annexed to and included within the City as effectually as if it had originally been a part thereof.
