WHEREAS: The progress of Free and Accepted Masonry, Prince Hall Affiliated is best inspired by the examples of Prince Hall, the first Grand Master of the Fraternity whose contributions to Freemasonry are recognized as superior by his Masonic Brothers; and

WHEREAS: The Most Worshipful Prince Hall Grand Lodge of Minnesota and Jurisdiction, Free and Accepted Masons, has demonstrated a commitment to community which wins the attention and esteem of those who are privileged to benefit from and share in united Prince Hall labors; and

WHEREAS: The quality of his efforts are reflected by his foundations as the first man of color (black) to be granted a Charter from the Grand Lodge of England, to meet as Masons in the New World, now the United States of America;
