

ORDINANCE NO. 67

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF GOODVIEW TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition dated April 17, 1982, requesting annexation of the territory hereinafter described was duly presented to the council on the 17th day of January 1983; and

WHEREAS, the quantity of land embraced within the area described is not exceeding $\frac{1}{2}$ acre of unplatted land, no part of which is included within the limits of an incorporated city, or borough; and

WHEREAS, the petition was signed by all owners,

WHEREAS, no objections to the annexation have been received from the town board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city limits at the westerly boundary thereof;

The Council of the City of Goodview, Minnesota, ordains:

Section 1. The City Council hereby determines (1) that the annexation will be to the best interests of the City and of the territory affected; (2) that the territory described herein abuts upon the City limits and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any City, or borough.

Section 2. Territory Annexed. The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:


That part of the Northeast Quarter of the Northeast Quarter of Section 13, Township 107, Range 8, Winona County, Minnesota, described as follows:

Commencing at the northeast corner of said Section 13; thence on an assumed bearing of South 1 degree 11 minutes 16 seconds East along the east line of said Northeast Quarter of the Northeast Quarter of Section 13, a distance of 854.15 feet; thence South 34 degrees 28 minutes 56 seconds West, 0.19 feet to a found iron pipe monument being on the southeasterly line of that certain property described in Deed Document No. 254168 as on file and of record in the office of the County Recorder, Winona County, Minnesota, and also being on the southerly line of Fifth Street and a Rollingstone Township Road; thence continuing southwesterly along the last described course, South 34 degrees 28 minutes 56 seconds West along said southeasterly line of said property described in Deed Document No. 254168, a distance of 173.03 feet to a found iron pipe monument marking the southeast corner of said property described in Deed Document No. 254168, said point being on the northerly right-of-way line of the Chicago, Milwaukee, St. Paul and Pacific Railroad; thence South 63 degrees 12 minutes 15 seconds East along said northerly railroad right-of-way line, 114.38 feet to its intersection with said east line of the Northeast Quarter of the Northeast Quarter of Section 13; thence North 1 degree 11 minutes 16 seconds West along said east line of the Northeast Quarter of the Northeast Quarter of Section 13, a distance of 194.16 feet to its intersection with said southerly line of Fifth Street; thence North 55 degrees 31 minutes 04 seconds West along said southerly line of Fifth Street, 0.13 feet to the point of beginning, containing 9,817.39 square feet, more or less.

Section 3. Filing. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, the Town Clerk, and the County Auditor.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.


