

WHEREAS, Lot 3, Lauerman's Gateway Subdivision is totally surrounded by the City of Olivia.


THE CITY COUNCIL OF THE CITY OF OLIVIA, ORDAINS AS FOLLOWS:

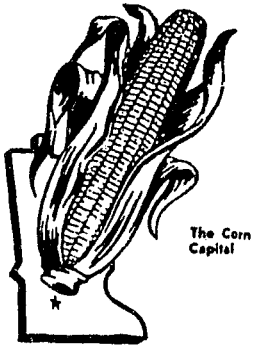


