- 1. The polling places and election judges shall be as follows:
 - a. The polling place in the Township of Pembina shall be the Pembina Town Hall.
 - b. The election judges in the Township of Pembina shall be:

FINDINGS OF FACT, CONCLUSIONS OF LAW, AND ORDER

The above-entitled matter came on for hearing before the Minnesota Municipal Board pursuant to Minnesota Statutes 414, as amended, on April 14, 1982, at Mahnomen, Minnesota and was continued to June 16, 1982. The hearing was conducted by Terrence A. Merritt, Executive Director, pursuant to Minnesota Statutes 414.01, Subdivision 12. Also in attendance were County Commissioners Fred Rothschadl and Richard Larson, Ex-Officio Members of the Board. The City of Mahnomen appeared by and through James Buening and the Town of Pembina appeared by and through A. J. Wambach, Jr. Testimony was heard and record and exhibits were received.

After due and careful consideration of all evidence, together with all records, files and proceedings, the Minnesota Municipal Board hereby makes and files the following Findings of Fact, Conclusions of Law, and Order.

FINDINGS OF FACT

1. On January 28, 1982 a resolution of the annexing municipality was received by the Minnesota Municipal Board requesting the Board to order annexation of the area hereinafter described. The resolution contained all the information required by statute including a description of the property subject to annexation which is as follows:

The Southwest Quarter of the Southeast Quarter and that part of the Northwest Quarter of the Southeast Quarter in Section 2,

Township 144 North, Range 42 West of the Fifth Principal Meridian in Mahnomen County, Minnesota, described as follows:

Commencing at the Southwest Corner of said Northwest Quarter of the Southeast Quarter; thence North 90 degrees 00 minutes 00 seconds East 1110.00 feet on an assumed bearing along the South line of said Northwest Quarter of the Southeast Quarter to the point of beginning; thence North 00 degrees 00 minutes 00 seconds East 1329.5 feet, more or less, to the North line of said Northwest Quarter of the Southeast Quarter; thence Easterly along the North line of said Northwest Quarter of the Southeast Quarter to the Northeast Corner of said Northwest Quarter of the Southeast Quarter; thence Southerly along the East line of said Northwest Quarter of the Southeast Quarter to the Southeast corner of said Northwest Quarter of the Southeast Quarter to the Southeast corner of said Northwest Quarter of the Southeast Quarter to the South line of said Northwest Quarter of the Southeast Quarter to the point of beginning.

- 2. Due, timely and adequate legal notice of the hearing was published, served and filed.
- 3. On June 23, 1983, the Minnesota Municipal Board moved to reduce the area under consideration before it to the following described property which is the subject of the remaining Findings of Fact, Conclusions of Law, and Order hereinafter:

The Southwest Quarter of the Southeast Quarter, Section 2, Township 144 North, Range 42 West, to the 5th Principal Meridian, in Mahnomen County, Minnesota.

- 4. The area subject to annexation is unincorporated, approximately 35 acres in size and abuts the City of Mahnomen by approximately 71% of its border. The City of Mahnomen is approximately 440 acres in size.
- 5. The area proposed for annexation is generally level, with U.S. Highway No. 59 and a portion of the northern side of Jefferson Avenue in the area.
- 6. In 1970 the City of Mahnomen had a population of 1,313 and its 1980 population is 1,283.
- 7. In 1970 the Town of Pembina had a population of 625 and its population in 1980 was 598.
- 8. In the area subject to annexation, the population in 1970 was 8, its population in 1980 was 9, and its current population is 9.

- 9. The City of Mahnomen has approximately 296 acres in residential use, approximately 25 acres in institutional use, approximately 12 acres in commercial use, and approximately 107 acres in agricultural use.
- 10. Pembina Township has approximately 297 acres in residential use, approximately 460 acres in institutional use, approximately 57 acres in commercial use, and approximately 22,010 acres in agricultural use.
- 11. In the area proposed for annexation, there are approximately 21 acres in commercial use with the remainder of the land in residential use or public purpose use.
- 12. The City of Mahnomen has a zoning ordinance, comprehensive plan, capital improvements program, fire code, Minnesota building code, Minnesota plumbing code, flood plain ordinance and sanitation ordinance.
 - 13. 'At the county level there is only lake shore zoning.
- 14. The present use of the area is consistent with the zoning for the area under the City of Mahnomen zoning plan.
- 15. The City of Mahnomen presently provides its residents with water, sanitary sewer, fire protection, police protection, street improvements and maintenance, administrative services, and street lights.
- 16. The City of Mahnomen presently provides the area proposed for annexation with street improvements and maintenance on that portion of Jefferson Avenue located in the annexation area, water and sanitary sewer to two of the businesses in the area, lights along Jefferson Avenue, police patrol to the area, police assistance through mutual aid to the County Sheriff, and fire protection paid for by the township under a contract arrangement.
- 17. If the area proposed for annexation were annexed, the city would be willing to extend water and sewer service to the remainder of the area proposed for annexation, should it be requested.
 - 18. The City of Mahnomen has erected a new watertower and is planning for

the expansion of its waste water treatment lagoons, so as to increase its capacity to serve the area proposed for annexation.

- 19. The Town of Pembina provides its residents with fire protection through a contract with the City of Mahnomen, road maintenance and improvements, and administrative services.
- 20. The mill levy for the County of Mahnomen is 39. The 1982 mill levy for the City of Mahnomen is 27.32. The 1982 mill levy for the Town of Pembina is 7.72. The 1982 mill levy for the school district is 40.36. The 1982 mill levy for the special taxing district is 1.51.
 - 21. The City of Mahnomen has a fire insurance rating of 7.
- 22. The City of Mahnomen has a bonded indebtedness, as of 12-31-81, of \$479,750.
 - 23. As of 12-31-81, the Town of Pembina had no bonded indebtedness.
 - 24. In 1982 the assessed valuation of the City of Mahnomen was \$3,331,238.
- 25. In 1982 the assessed valuation of the Town of Pembina was approximately \$3,238,341.
- 26. In 1982 the assessed valuation of the area proposed for annexation was approximately \$163,474.
- 27. Pembina Township can continue to function without the area subject to annexation.
- 28. The City of Mahnomen is the only municipality adjacent to the area subject to annexation.
- 29. The proposed annexation will have no impact on the school district, which serves the area proposed for annexation.
- 30. All necessary governmental services can best be provided to the area subject to annexation by annexation to the City of Mahnomen.
 - 31. The majority of the property owners in the area subject to annexation

have not petitioned the Minnesota Municipal Board requesting annexation.

CONCLUSIONS OF LAW

- 1. The Minnesota Municipal Board duly acquired and now has jurisdiction of the within proceeding.
- 2. The area subject to annexation is now or is about to become urban or suburban in nature and the annexing municipality is capable of providing the services required by the area within a reasonable time.
- 3. Municipal government is required to protect the public health, safety and welfare in the area subject to annexation.
- 4. The best interests of the area subject to annexation will be furthered by annexation.
- 5. The remainder of the Town of Pembina can carry out the functions of government without undue hardship.
- 6. There is a reasonable relationship between the increase in values for the City of Mahnomen and the value of benefits conferred upon the area subject to annexation.
- 7. The City of Mahnomen is the only city adjacent to the area proposed for annexation, therefore the annexation of all or a part of the property to an adjacent municipality would not better serve the interests of the residents who reside in the area subject to annexation.
- 8. Pursuant to M.S. 414.035, the mill levy step-up for the area proposed for annexation is 6 years.
 - 9. This Minnesota Municipal Board order is subject to an annexation election.
- 10. An order should be issued by the Minnesota Municipal Board annexing the area described in Findings of Fact 3, herein.

ORDEF

1. IT IS HEREBY ORDERED: That the property described in Findings of Fact 3, herein, situated in the County of Mahnomen, State of Minnesota, be and the same is

hereby annexed to the City of Mahnomen, Minnesota, the same as if it had been originally made a part thereof.

- 2. IT IS FURTHER ORDERED: On November 8, 1983, which is 77 days after the entry date of this order, a public election, to be conducted as provided by law, shall be held in the entire City of Mahnomen and the entire Town of Pembina, which is the area that has been determined by the Minnesota Municipal Board to be primarily and substantially interested in or affected by the Minnesota Municipal Board order. Further, any person eligible to vote at a township or municipal election is eligible to vote at such election. The ballot for said election shall conform substantially to the following:
 - // For Annexation // Against Annexation
- 3. IT IS FURTHER ORDERED: That Dean M. Johnson is hereby appointed as Chief Election Judge and Vincent Kettner is hereby appointed as Deputy Chief Election Judge. Further, a Supplemental Order of the Board shall be issued appointing election judges and naming polling places. The local judges shall conduct the election so far as practicable in accordance with the laws regulating special elections. Further, the referendum shall be conducted as provided for in Minnesota Statutes 414.031, Subdivision 5. The polls shall be open from 7:00 a.m. to 8:00 p.m.
- 4. IT IS FURTHER ORDERED: That the mill levy of the City of Mahnomen on the property herein ordered annexed shall be increased in substantially equal proportions over a period of six years to equality with the mill levy of the property already within the city.
- 5. IT IS FURTHER ORDERED: That the population of the City of Maintonen has been increased by 9 persons.
- 6. IT IS FURTHER ORDERED: That the population of the Town of Pembina has been decreased by 9 persons.

- 7. IT IS FURTHER ORDERED: That the annexation herein be effective January 1, 1984 provided that a majority of the votes are cast "for annexation." The Municipal Board shall upon receipt of the certificate of election results, notify all parties of record of the election results.
- 8. IT IS FURTHER ORDERED: That the effective date of this order is August 23, 1983.
