
The Minnesota Municipal Board has now processed and approved the above ordinance in accordance with Minnesota Statutes, Chapter 414, and the Rules of Procedure.

ORDINANCE NO. 617

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF STILLWATER INTO CERTAIN UNINCORPORATED TERRITORY COMPLETELY SURROUNDED BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, or borough; and

WHEREAS, this territory is completely surrounded by lands already included within the corporate limits of the city and is deemed to be urban or suburban in character;

NOW THEREFORE, the City Council of the City of Stillwater ordains:

Section 1. Territory Annexed. The corporate limits of the City of Stillwater, Minnesota, are hereby extended to include the unplatted territory described as follows, (which territory now is and has heretofore been completely surrounded by territory already included within the city limits):

The East 160 feet of the South 275 feet of the real estate described as: All that part of the Southeast Quarter of the Southeast Quarter (SE $\frac{1}{4}$ of SE $\frac{1}{4}$) of Section Twenty (20), Township Thirty (30), Range Twenty (20) described as follows: Beginning at a point on the East line of the above described tract of land Six hundred fifty (650) feet North of the Southeast corner thereof and running thence West parallel to the North line of said tract of land Six hundred twenty-five (625) feet; thence North parallel to the East line of said tract to the North line of said tract; thence East along the North line of said tract to the center of the public road known as the Government Road; thence Southeasterly along the center line of said Road to the East line of the above described tract of land; thence South to the place of beginning. According to the United States Government Survey thereof, Washington County, Minnesota; and

All that part of the Southeast Quarter of the Southeast Quarter (SE $\frac{1}{4}$ of SE $\frac{1}{4}$) of Section Twenty (20), Township Thirty (30), Range Twenty (20), described as follows, to-wit:


Commence at the Southeast corner of Section Twenty (20), Township Thirty (30), Range Twenty (20), thence North along the East line of said Section Twenty (20), Township Thirty (30), Range Twenty (20), for Six hundred fifty (650) feet; thence West and parallel with the North line of Southeast Quarter of Southeast Quarter (SE $\frac{1}{4}$ of SE $\frac{1}{4}$) of Section Twenty (20), Township Thirty (30), Range Twenty (20), for One hundred sixty (160) feet to the point of beginning of this description; thence West and parallel with the said North line of Southeast Quarter of Southeast Quarter (SE $\frac{1}{4}$ of SE $\frac{1}{4}$) of Section Twenty (20), Township Thirty (30), Range Twenty (20) for Two hundred seventy-five (275) feet; thence North

and parallel with the East line of said Southeast Quarter of Southeast Quarter (SE $\frac{1}{4}$ of SE $\frac{1}{4}$) of Section Twenty (20), Township Thirty (30), Range Twenty (20), for Two hundred seventy-five (275) feet; thence East and parallel with said North line of Southeast Quarter of Southeast Quarter (SE $\frac{1}{4}$ of SE $\frac{1}{4}$) of Section Twenty (20), Township Thirty (30), Range Twenty (20), for Two hundred seventy-five (275) feet; thence South and parallel with said East line of said Section Twenty (20), Township Thirty (30), Range Twenty (20), for Two hundred seventy-five (275) feet to the point of beginning, and containing One and seventy-five hundredths (1.75) acres, more or less, Washington County, Minnesota.

Section 2. Filing. The City Clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of Washington County, Minnesota, the Town Clerk of the Township of Stillwater, and the Minnesota Municipal Commission.




