
The Minnesota Municipal Board has now processed and approved the above ordinance in accordance with Minnesota Statutes, Chapter 414, and the Rules of Procedure.

AN ORDINANCE TO AMEND AN ORDINANCE  
KNOWN AS CHAPTER 13, UNCODED ORDINANCES  
IN EFFECT OF THE CITY CODE OF THE  
CITY OF MANKATO, MINNESOTA

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village, or borough; and

WHEREAS, this territory is completely surrounded on all sides by lands already included within the corporate limits of the City, does not exceed 200 acres and is deemed to be or about to become urban or suburban in character;

THE CITY OF MANKATO, HEREBY ORDAINS THAT:

1. The annexation will be to the best interest of the City and of the land affected.
2. The land described herein is surrounded by the City and is or is about to become urban or suburban in character.
3. That none of said land is now included within the limits of any city, village, or borough.
4. That annexation of this parcel will enhance the City's ability to plan for utilities and streets in this part of the City as well as control future development.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Mankato that the corporate limits of the City are hereby extended to include the land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been part thereof:

The North half of the North half of the South half of the Southeast Quarter; the South half of the South half of the North half of the Southeast Quarter; the North 26 acres of the Southeast Quarter; the South 34 acres of the North 60 acres of the Southeast Quarter, all in Section 20, Township 108 North, Range 26 West, except Lots 1 through 9, Block 1, Mankato Industrial Park.

The City Clerk is hereby directed to file certified copies of the ordinance with the Minnesota Municipal Commission, the Secretary of State, the County Auditor and Mankato Township.

This ordinance shall take effect 30 days after the date of its passage and due publication and filing thereof.

Adopted this 23rd day of May, 1983.

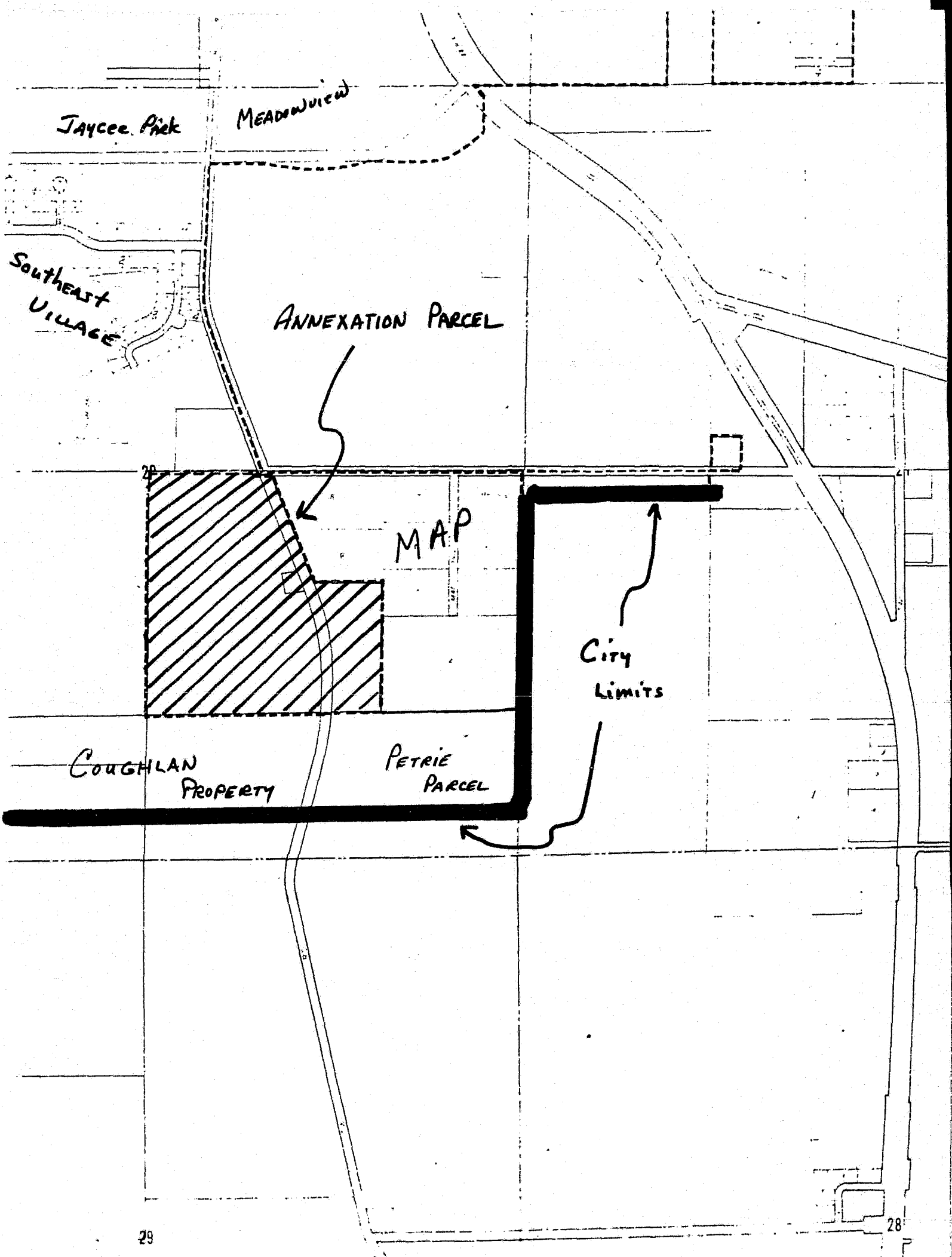
