
The Minnesota Municipal Board has now processed and approved the above ordinance in accordance with Minnesota Statutes, Chapter 414, and the Rules of Procedure.



RESOLUTION FOR ANNEXATION

At a regular meeting of the Center City Council held on the 5th day of May, 1983, at the Municipal Chambers in said City, Councilman Ron Elmquist introduced and moved for the adoption of the following resolution:

WHEREAS, a Petition for Annexation dated February 28, 1983 was submitted to the Council on said date, same requesting that the following described parcels be annexed to the City of Center City, MN:

Government Lot four (4) Section Thirty-four (34) Township Thirty-four (34), Range Twenty (20) West and copies of said Petition were filed with the Minnesota Municipal Board, the City Council of Lindstrom and the W Town Board of Chisago Lakes, and said Petition consists of platted property not exceeding 200 acres in size, and said Petition was signed by all owners of the property described in said Petitions, and

WHEREAS, no written objections to the proposed annexation have been received by Minnesota Municipal Board or the City Council of Center City within the 90-day period provided by law:

NOW THEREFORE BE IT RESOLVED BY THE CENTER CITY COUNCIL that the above described property be annexed to the City of Center City and be made a part thereof, by ordinance and that Chapter 503 of the code of ordinances of the City of Center City, MN, entitled "Annexations," be amended by the addition of Section 503.03 to read in its entirety as follows:

503.03. Annexation #4.

The corporate limits of the City are hereby modified and extended to include the platted lands described as follows, the same being hereby annexed to and included within said City the same as if said lands had originally been a part thereof:
