AN ORDINANCE OF THE CITY OF NORTH MANKATO, MINNESOTA DECLARING CERTAIN LAND TO BE ANNEXED TO SUCH CITY, IDENTIFIED AS RICHARD H. JOHNSON PROPERTY.

THE CITY COUNCIL OF THE CITY OF NORTH MANKATO, MINNESOTA ORDAINS:

Section 1. The following tract of unincorporated property abuts upon the municipal limits of the City of North Mankato, Minnesota.

Section 2. The legal description of said land is shown upon Exhibit A, attached hereto and the same is incorporated herein by reference.

Section 3. Such land is now or is about to become urban or suburban in character.

Section 4. Such land is owned by the City of North Mankato, Minnesota or is completely surrounded by land within the municipal limites of such city.

Section 5. The land proposed for annexation is platted.

Section 6. Such land is hereby annexed to the City of North Mankato, Minnesota and is declared to be included within its municipal limits.

Section 7. After adoption, signing and attestation, this ordinance shall be published once in the official newspaper of the City and shall be in effect on and after the day following such publication and the date this ordinance is approved by the Municipal Board of the State of Minnesota.






