## ALL URBAN TOWNS

Will you please assist us in our effort to compile a correct list of Minnesota townships that are exercising urban town powers?

Since the passage in 1982 of the new urban town powers bill, we get frequent requests for lists of towns which are exercising urban town powers. HUD is presently compiling an eligibility list for UDAG Grants and is requesting our assistance on your behalf.

Pursuant to MSA 368.01 sec. 30, you are required to file your intent to exercise urban town powers to the office of the Secretary of State. If you have not already done so, the best method is to send a copy of your resolution adopting urban town powers with a letter from the clerk certifying that it is a true and correct copy of resolution adopted at (date) meeting. Send that to: Official Documents Registration, Office of Secretary of State, 180 State Office Building, St. Paul, Minnesota 55155.

more. A \$100,000 investigation of arsenic burial sites is scheduled in addition to projects at Perham, Morris and Wadena which will determine how to prevent arsenic buried at those sites from endangering human health. At Perham and Wadena, the MPCA is conducting the investigation, while at Morris the U.S. Environmental Protection Agency is taking the lead.
