ORDER

WHEREAS, a petition for the annexation of certain land to the City of Hastings was filed with the Minnesota Municipal Board on July 22, 1983; and

WHEREAS, an objection by Marshan Township to said petition was received on August 8, 1983; and

WHEREAS, a hearing was convened on said petition for annexation of certain land to the City of Hastings on November 23, 1983; and

WHEREAS, the hearing on the aforementioned matter has been continued to June 6, 1984 at Hastings, Minnesota; and

WHEREAS, said hearing was continued to allow for discussions for orderly annexation between the Town of Marshan and the City of Hastings; and

WHEREAS, the City of Hastings and the Town of Marshan have executed an orderly annexation agreement which contains in the orderly annexation agreement area the property described in said petition; and

WHEREAS, counsel for the property owners of said land has, by letter dated May 22, 1984, requested that the board allow the withdrawal of said petition;

IT IS HEREBY ORDERED: That the above-entitled petition may be withdrawn and the Minnesota Municipal Board file on said petition is hereby

closed without prejudice. The property description in said petition is described as follows:

The West half of the North half of the Southwest quarter (W 1/2 of N 1/2 of SW 1/4) of Section Two (2), Township One Hundred Fourteen (114), Range Seventeen (17), according to the Government Survey thereof.

The Southeast quarter (SE 1/4) of Section Three (3), Township One Hundred Fourteen (114), Range Seventeen (17), according to the Government Survey thereof, EXCEPTING THEREFROM that part described as follows: Beginning at a point, which point is the Northwest corner of said Southeast quarter (SE 1/4); thence South on said West line 240.29 feet; thence South 89° 07' 53" East for a distance of 1213.35 feet, more or less, to the centerline of State Trunk Highway No. 316; thence Northwesterly along said centerline for 319.40 feet, more or less, to the North line of said Southeast quarter (SE 1/4); thence North 89° 51' 53" West along said North line for 1018.80 feet to the point of beginning.

IT IS FURTHER ORDERED: That the hearing on said petition scheduled for June 6, 1984, is cancelled.

IT IS FURTHER ORDERED: That the effective date of this order is May 30, 1984.
