EINDINGS OF FACT CONCLUSIONS OF LAW AND\_ORDER

On May 23, 1984, the Minnesota Municipal Board received a petition by all of the property owners for the detachment of certain land from the City of Rockville. A resolution for the detachment of the same land was received from the City of Rockville on the 23rd day of May, 1984.

After review of the petition and resolution, the Minnesota Municipal Board hereby makes and files the following Findings of Fact, Conclusions of Law, and Order.

## FINDINGS OF FACT

1. That a petition was duly filed with the Municipal Board by the requisite number of property owners and a resolution for the detachment of the same property was filed by the City of Rockville.

2. The petition and resolution contained all the information required by statute including a description of the territory proposed for detachment, which is as follows:

Section 9, Township 123, Range 29 .64 acre, east 74 feet of north 327.11 and west 166 feet of north 21.86 of east 240 of w/2, sw/4, se/4.

3. The area proposed for detachment is situated within the City of Rockville and abuts the municipal boundary.

4. The area proposed for detachment is .64 acre.

5. The area proposed for detachment is rural in character and not

developed for urban residential, commercial, or industrial purposes.

6. The area proposed for detachment abuts the Town of Rockville.

7. There are no people, buildings, or municipal improvements on the area proposed for detachment.

## CONCLUSIONS OF LAW

1. The Minnesota Municipal Board duly acquired and now has jurisdiction of the within proceeding.

2. The area subject to detachment is rural in character and not developed for urban residential, commercial, or industrial ourposes.

3. The detachment would not unreasonably affect the symmetry of the detaching municipality.

4. The area subject to detachment is not needed for reasonablyanticipated future development.

5. The remainder of the municipality can continue to carry on the functions of government without undue hardship.

6. An order should be issued by the Minnesota Municipal Board detaching the area described herein.

# ORDER

1. IT IS HEREBY ORDERED: That the property described herein in Findings of Fact 2 be, and the same hereby is, detached from the City of Rockville and made a part of the Township of Rockville, the same as if it had originally been made a part thereof.

2. IT IS FURTHER ORDERED: That the effective date of this order is June 14, 1984.
