ORDINANCE NO. 134

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF CHISAGO CITY TO INCLUDE CERTAIN UNINCORPORATED TERRITORY BORDERED BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON.

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, or borough; and

WHEREAS, 60% or more of the perimeter of this territory is bordered by lands already included within the corporate limits of the city and is deemed to be urban or suburban in character;

The City Council of Chisago City ordains;

Section 1. Territory annexed. The corporate limits of the City of Chisago City, Minnesota, are hereby extended to include the platted territory described as follows, 60% or more of the perimeter of which territory is bordered by territory already included within the City limits:

Lots 1 thru 19 and Lot 019 of Maple Beach subdivision plus Pt of Lot 52 of Chisago Villas des as fol bg at SE cor of Lot 55 th W along S line of Lot 55, the W along S line of Lot 55, 428 ft th N at Rt ang 453.6 ft to Pt of bg th N 76.4 ft to intersection with N line of Lot 52 th W along N line of Lot 52, 360 ft M or L to E'ly shore line of Green Lake th S'ly along E'ly shore line of Green Lake 78 ft M or L th E & Par & S 76.4 ft of N line of Lot 52 376 ft to Pt of bg. Chisago Villas.

Section 2. Filing. The City Clerk is directed to file certified copies of this Ordinance with the Secretary of State, the County Auditor of the County in which the property is located, the Town Clerk of the affected township and the Minnesota Municipal Board.

Section 3. Effectived Date of Annexation. The Ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 2 and approval by the Minnesota Municipal Board.
