



ORDER

WHEREAS, a petition for the annexation of certain land to the City of Hastings was filed with the Minnesota Municipal Board on November 15, 1982; and

WHEREAS, an objection by Marshan Township to said petition was received on December 2, 1982; and

WHEREAS, a hearing was held on said petition for annexation of certain land to the City of Hastings on January 26, 1983 and February 10, 1983; and

WHEREAS, during the Board's deliberation on the evidence, presented at said hearings, the Board urged the Town of Marshan and the City of Hastings to discuss the development of an orderly annexation agreement between the two units of government; and

WHEREAS, the City of Hastings and the Town of Marshan have executed an orderly annexation agreement, which contains in the orderly annexation agreement area the property described in said petition; and

WHEREAS, Article 3 of said orderly annexation agreement provides for the immediate annexation of the property described as Hastings Construction Company property, whose owners had initiated the aforementioned petition for the annexation of that land to the City of Hastings; and

WHEREAS, the Minnesota Municipal Board pursuant to the orderly annexation agreement has ordered the annexation of the property described as Hastings Construction Company property; and

WHEREAS, the specific addressing of the Hastings Construction Company area in the orderly annexation agreement constitutes a request to withdraw the petition;

IT IS HEREBY ORDERED: That the Minnesota Municipal Board allows the withdrawal of the aforementioned petition and file A-3966 is hereby closed without prejudice.

IT IS FURTHER ORDERED: That the effective date of this order is June 26, 1984.
