ORDINANCE NO. 164

The City Council of the City of New Richland does ordain that:

A Petition for Annexation, pursuant to Minnesota Statutes 414.033

subdivision 5 was filed and received by the City Council on March 12, 1984.

Said Petition affects the following described property:

Commencing at the southeast corner of Block 8, Zieger's Subdivision, in the City of New Richland, as the same is platted and recorded in the office of the County Recorder of Waseca County, Minnesota;

thence south 40.00 feet on a southerly extension of the east line of said Block 8, to a point on the centerline of Northwest Second Street, which point is the point of beginning;

thence west 690.00 feet, at a deflection angle of $89^{\circ} 54' 15''$ right, on the centerline of said Northwest Second Street;

thence south 166.00 feet, at a deflection angle of $89^{\circ} 54' 15''$ left;

thence east 312.00 feet, at a deflection angle of $90^{\circ} 05' 45''$ left;

thence south 14.00 feet, at a deflection angle of $90^{\circ} 05' 45''$ right;

thence east 238.00 feet, at a deflection angle of $90^{\circ} 05' 45''$ left;

thence south 176.00 feet, at a deflection angle of $90^{\circ} 05' 45''$ right;

thence east 173.00 feet, at a deflection angle of $90^{\circ} 05' 45''$ left, to a point on the centerline of North Cedar Avenue;

thence north 356.00 feet, at a deflection angle of $89^{\circ} 54' 15''$ left, on the centerline of said North Cedar Avenue, to a point on the centerline of said Northwest Second Street;

thence west 33.00 feet, at a deflection angle of $90^{\circ} 05' 45''$ left, on the centerline of said Northwest Second Street, to the point of beginning;

being part of Block 5 & 6 and the $S\frac{1}{2}$ of Northwest Second Street (vacated) and part of the $W\frac{1}{2}$ of North Cedar Avenue in said Zieger's Subdivision, in the City of New Richland, Minnesota;

containing 3.59 acres more or less;

subject to easements of record.

Said property abuts the current boundaries of the City of New Richland.

No objections to this proposed Petition for Annexation have been filed or received by the City of New Richland.

It is determined that the property proposed for annexation is now and is about to become urban or suburban in character.

THEREFORE, the said above described property is hereby annexed and incorporated into the boundaries of the City of New Richland.


