

FINDINGS OF FACT,
CONCLUSIONS OF LAW,
AND ORDER

On July 5, 1984, the Minnesota Municipal Board received a resolution from the City of South International Falls, which requested the detachment of certain property and the City of International Falls, which requested the annexation of the same territory pursuant to Minnesota Statutes 414.061.

After review of the resolutions, the Minnesota Municipal Board hereby makes and files the following Findings of Fact, Conclusions of Law, and Order.

FINDINGS OF FACT

1. That a resolution supporting detachment of certain properties was received from the City of South International Falls and a resolution supporting annexation of said property was received from the City of International Falls.

2. The resolutions contained all the information required by statute including a description of the territory proposed for detachment and annexation, which is as follows:

That part of platted street, dedicated for public use, located in the Plat of First Addition to Mertens Acres in Gov't. Lots 3 and 4, Sec. 3, T-70-N, R-24-W, Koochiching County, Minnesota, described as follows;

Beginning at a point on the north line of Gov't. Lot 4, Sec. 3, T-70-N, R-24-W where said north line intersects the east line of Ninth Avenue; thence running east on and along the north line of Gov't. Lots 4 and 3 a distance of 763.2 feet to the westerly right of way of the Burlington Northern Railroad; thence running in a southwesterly direction on and along the said westerly right of way line of the Burlington Northern Railroad to a point which is 33 feet

at a perpendicular to said north line of Gov't. Lots 4 and 3; thence running west parallel with and at a distance of 33 feet from said north line of Gov't. Lots 4 and 3 to the east line of said Ninth Avenue; thence running north along said east line of Ninth Avenue 33 feet to the point of beginning.

And that part of Ninth Avenue located in Gov't. Lot 4, Sec. 3, T-70-N, R-24-W, Koochiching County, Minnesota described as follows;

Beginning at a point on the north line of Gov't. Lot 4, Sec. 3, T-70-N, R-24-W, where said north line intersects the east line of Ninth Avenue; thence running west on and along the north line of Gov't. Lot 4 a distance of 66 feet to the westerly right of way of Ninth Avenue; thence running south on and along the said westerly right of way line of Ninth Avenue 33 feet; thence running east parallel with and at a distance of 33 feet from said north line of Gov't. Lot 4 to the east line of said Ninth Avenue; thence running north along said east line of Ninth Avenue 33 feet to the point of beginning.

3. The area proposed for detachment is situated within the City of South International Falls and abuts the City of International Falls.

CONCLUSIONS OF LAW

1. The Minnesota Municipal Board duly acquired and now has jurisdiction of the within proceeding.

2. An order should be issued by the Minnesota Municipal Board concurrently detaching and annexing the area described herein.


ORDER
