

PETITION FOR THE INCORPORATION OF VILLAGE OF COSMOS

To the Honorable Board of County Commissioners of the County of Meeker and State of Minnesota.

The undersigned legal voters who reside within the territory herein petitioned to be incorporated, do hereby respectfully petition your board to call an election for the determination of the proposed incorporation of Village of Cosmos, and to appoint three inspectors residents of said territory to act as Judges of said election.

Your petitioners further state that on the 9th. day of August, 1926, they caused to be taken a census of the resident population of the territory herein proposed to be incorporated, and that the number of actual residents thereon was on said day and is now One Hundred Ninety-five (195) persons.

That the territory hereby proposed to be incorporated consists of the Southwest Quarter (SW $\frac{1}{4}$ ) of Section Fifteen (15), the Southeast Quarter (SE $\frac{1}{4}$ ) of Section Sixteen (16), the Northeast Quarter (NE $\frac{1}{4}$ ) of Section Twenty-one (21), and the Northwest Quarter (NW $\frac{1}{4}$ ) of Section Twenty-two (22), all in Township One Hundred Seventeen (117) of Range Thirty-two (32), in Meeker County, Minnesota; that the said territory consists of Six Hundred Forty (640) acres according to Government Survey, and is bounded as follows: Commencing at the center of Section Fifteen (15), Town and Range aforesaid, running thence West about one mile to the center of Section Sixteen (16), running thence South about one mile to the center of Section Twenty-one (21), running thence East about one mile to the center of Section Twenty-two (22), running thence North about one mile to the point of beginning, all in Township and Range aforesaid, that no part of said territory is within any incorporated village.

The name of the Village proposed to be incorporated shall be "Village of Cosmos", and the said territory embraces all the platted lands included within the following named plats, all of which are on file and of record in the office of the Register of Deeds of said Meeker County, to-wit;

R E S O L U T I O N

WHEREAS, A petition of more than twenty-five legal voters residing in the territory proposed to be incorporated as "Village of Cosmos", which territory is described as follows, to-wit;

SW $\frac{1}{4}$  of Sec. 15; SE $\frac{1}{4}$  of Sec. 16; NE $\frac{1}{4}$  of Sec. 21; and NW $\frac{1}{4}$  of Sec. 22, all in Township 117 of Range 32, in Meeker County, Minnesota, has been filed with the Board of County Commissioners of said Meeker County, representing that the said petitioners have caused a census to be taken of the persons who are actual residents of said territory, and that said census shows that there are 195 actual residents therein; and praying that the said Board fix a time and place for the holding of the election on said proposed incorporation, and that it appoint three inspectors to act as judges of said election, and

WHEREAS, The said Board of County Commissioners hereby in all things approves said petition,

THEREFORE, BE IT RESOLVED, That the election on said proposed incorporation be held at the Cosmos Town Hall within said territory on the 14th. day of September, 1926, between the hours of 9 o'clock A. M. and 9 o'clock P. M. of said day, and that the following named three residents of said territory, viz; Ernest Grussendorf, A. G. Abrahamson and Chas. J. Larson be and hereby are appointed inspectors who shall act as Judges of said election, and shall make their certificate thereof in accordance with law;

BE IT FURTHER RESOLVED, That notice of said election be posted in three public places within said territory as required by law.
