consented and described in the map hereto attached marked Exhibit "A" and
made a part hereof, as Eveleth Central Division No. 1 and Royal Addition
to Eveleth, more particularly described as, that portion of the North-
west quarter (N.W. 1/4) of the Southwest quarter (S.W. 1/4) of Section
Thirty-two (32) Township Fifty-eight (58) Range Seventeen (17) West, com-
prised within the area platted as Eveleth Central Division No. 1 accord-
ing to the recorded plat thereof on file and of record in the office of
the Register of Deeds for St. Louis County, and the West Four Hundred
Three (403) Feet of the Southwest quarter (S.W. 1/4) of the Southwest
quarter (S.W. 1/4) of Section Thirty-two (32) Township Fifty-eight (58)
Range Seventeen (17) West, being portion carried within the area
platted as Royal Addition to Eveleth according to the plat thereof on
