ORDER

WHEREAS, a petition for the annexation of certain land to the City of St. Francis was filed with the Minnesota Municipal Board on February 6, 1984; and

WHEREAS, an objection by Oak Grove Township to said petition was received on April 30, 1984; and

WHEREAS, a hearing was convened on said petition for the annexation of certain land to the City of St. Francis on August 9, 1984; and

WHEREAS, the hearing on the aforementioned matter has been continued to November 7, 1984 at St. Francis, Minnesota; and

WHEREAS, said hearing was continued to allow for discussions for orderly annexation between the Town of Oak Grove and the City of St. Francis; and

WHEREAS, the City of St. Francis and the Town of Oak Grove have executed an orderly annexation agreement which contains in the orderly annexation agreement area a portion of the property described in said petition; and

WHEREAS, the property owners of said land have, by letter received

September 14, 1984, requested that the board allow the withdrawal of said petition:

IT IS HEREBY ORDERED: That the above-entitled petition may be withdrawn and the Minnesota Municipal Board file on said petition is hereby closed without prejudice. The property description in said petition is described as follows:

That part of the Northeast Quarter of the Northeast Quarter of Section 5, Township 33, Range 24 described as follows: Beginning at a point of the North line of said Northeast Quarter a distance of 300 feet West of the Northeast corner thereof, thence West on said North line a distance of 150 feet, thence South parallel to the East line of said Northeast Quarter of the Northeast Quarter a distance of 300 feet, thence East parallel to the North line of said Northeast Quarter of Northeast: Quarter a distance of 150 feet, thence North to the point of beginning, according to the United States Government Survey thereof and situated in Anoka County, Minnesota.

That part of the Northeast Quarter of the Northeast Quarter of Section, Township 33, Range 24, described as follows: Commencing at the Northeast corner of the Northeast Quarter of the Northeast Quarter, thence West 300 feet thence South 300 feet; thence East 300 feet; thence North 300 feet to the point of beginning, according to the United States Government Survey thereof and situated in Anoka County, Minnesota.

That part of the Northeast Quarter of the Northeast Quarter of Section 5, Township 33, Range 24, described as follows: Commencing at a point on the East line of said Northeast Quarter of the Northeast Quarter distant 500 feet South of the Northeast corner thereof; thence West on a line at right angles to the East line of said Northeast Quarter of the Northeast Quarter a distance of 450 feet to the point of beginning of the land to be described; thence South on a line parallel with the East line of said Northeast Quarter of the Northeast Quarter a distance of 350 feet; thence West at right angles a distance of 208.69 feet; thence North and parallel with the East line of said Northeast Quarter of the Northeast Quarter and to a point distant 300 feet South of the North line of said Northeast Quarter of the Northeast Quarter as measured along the West line thereof;

Thence West and parallel with the North line of said Mortheast Quarter of the Northeast Quarter and to a point distant 363

East of the West line of said Northeast Quarter of the Northeast as measured along the North line thereof, thence North and parallel with the West line of said Northeast Quarter of the Northeast Quarter and to the North line thereof; thence East on the North line of said Northeast Quarter of the Northeast Quarter and to a point on a line drawn Northerly from the point of beginning and parallel with the East line of said Northeast Quarter of the Northeast Quarter; thence South and parallel with the East line of said Northeast Quarter of the Northeast Quarter and to the point of beginning, according to the United States Government Survey thereof and situated in Anoka County, Minnesota.

IT IS FURTHER ORDERED: That the hearing on said petition scheduled for November 7, 1984 is cancelled.

IT IS FURTHER ORDERED: That the effective date of this order is October 4, 1984.
