An ordinance annexing land into the City of Fosston

Section 1. RECITALS,

A. WHEREAS, the City of Fosston owns following described real property abutting said City:

---That part of the Southeast Quarter of the Northwest Quarter (SEZNWZ) of Section Four (4), Township One Hundred Forty-seven (147) North of Range Forty (40) West of the Fifth Principal Meridian, described as follows, to-wit: Commencing at a point on the East line of said SELNWL of Sec. 4 which is 589 feet North of the center of the said Sec. 4, thence West and parallel with the South line of said Sec. 4 a distance of 320 feet, thence North and parallel with the East line of said Sec. 4, a distance of 13.7 feet, thence West and parallel with the South line of said Sec. 4 a distance of 526 feet, thence North and parallel with the East line of said Sec. 4 a distance of 724.6 feet more or less to the North line of the SEXNW% of said Sec. 4, thence East on the North line of said SEXNW% a distance of 846 feet more or less to the Northeast corner of the SE%NW%, thence Southerly to the point of beginning, Polk County, Minnesota.---


