ORDINANCE NO. 531

AN ORDINANCE ANNEXING CERTAIN LANDS (CITY MARSH) INTO THE CITY OF WASECA, MINNESOTA, AND ESTABLISHING ZONING THEREOF

WHEREAS, the land described below is owned by the City of Waseca, and

WHEREAS, Minnesota Statutes 414.033 (2a), authorizes a municipal council to annex land that is owned by the municipality by ordinance, and

WHEREAS, the Waseca City Council deems the land described below to be urban or suburban in character or about to become so.

NOW, THEREFORE, THE CITY OF WASECA DOES ORDAIN:

Section 1. That there is hereby annexed into and included within the City of Waseca, Minnesota, the following described land in the County of Waseca, State of Minnesota, as described below:

Beginning at the North One-Quarter Corner of Section 8, Township 107 North, Range 22 West; thence South 89 degrees 38 minutes 39 seconds east on the North line of Section 8, for a distance of 664.95 feet; thence S 00°-33'-31"E, 336.3 feet; thence S 89°-01'-37" E, 136.31 feet; thence S 06°-30'43"E, 139.0 feet; thence S 83°-50'-58" W, 134.77 feet; thence S 64°-50'-01" W, 122.15 feet; thence S 32°-53'-19"W, 333.93 feet; thence S 14°-28'-33"W, 425.82 feet; thence S 04°-32'-49" W, 466.25 feet; thence S 26°-57'-55" W, 69.66 feet; thence S 89°-46'-16"W, 158.89 feet; thence S 46°-12'-29"W, 58.92 feet; to the North and South centerline of Section 8; thence S 00°-33'-31"E on the North and South centerline of Section 8, a distance of 242.40 feet; thence S 89°-58'-17"W, 33.00 feet; thence S 00°-33'-31"E, 570.00 feet; thence N 89°-58'-17"W, 531.05 feet; thence N 48°-57'-16"W, 305.59 feet; thence N 00°-12'-39"W, 1,279.60 feet; thence N 32°-09'-19"E, 564.10 feet to the Southwest corner of Lot 14, Block 5, Northridge Addition, thence N 90°-00'-E along the South line of Block 5, Northridge Addition a distance of 480.29 feet; said point being on the North and South centerline of Section 8; thence N 00°-33'-31"W on the North and South centerline of Section 8, a distance of 662.75 feet to the point of beginning, containing 50.85 acres.


ORDINANCE NO. 531

Section 2. That the annexed land shall be zoned within the meaning of the zoning ordinances and codes of the City of Waseca as R-2 Residential.

Section 3. That a certified copy of this ordinance shall be filed with the Minnesota Municipal Commission, the Secretary of State of Minnesota, the Waseca County Auditor, the Waseca County Register of Deeds and the Clerk of the Woodville Township Board.

Section 4. That this ordinance shall be effective upon passage and legal publication in the filing of the certified copies as described in Section 3.
