## RESOLUTION FOR McLEOD REGIONAL RAIL AUTHORITY

The following Resolution was offered by Commissioner <u>Wacker</u>
and seconded by Commissioner <u>Fiecke</u>:

WHEREAS, under the provisions of Minnesota Statutes \$398A.01 - 398.09, the Legislature of the State of Minnesota has authorized the governing body of counties or municipalities to organize by resolution regional rail authorities for the purpose of the preservation and improvement of local rail service for agriculture, industry, or passenger traffic when deemed to be practical and necessary for public welfare, particularly in the case of possible abandonment of local rail lines; and

WHEREAS, the County of McLeod, a governing body authorized by law to exercise governmental powers, has determined that a regional rail authority acting under the laws of Chapter 398A (Regional Railroad Authorities Act), is necessary for the purpose of preserving and improving local railroad service, and that the preservation of such railroad service is in the best interests of the public welfare; and

WHEREAS, the County of McLeod desires to establish a railroad authority for the purpose of advancing the objectives, powers, and purpose of M.S.A. 398A and at the same time maintaining to the extent feasible and practical, the autonomy and authority of the county;

## NOW BE IT THEREFORE RESOLVED:

- 1. That the McLeod Regional Rail Authority be established and organized under the Regional Railroad Authorities Act, Chapter 398A.01 398A.09, as a political sub-division and local government unit of the State of Minnesota, to exercise thereunder part of the sovereign power of the State;
- 2. That the name of the authority shall be McLeod Regional Railroad  $\gamma$

- 3. The county adopting the organization Resolution is the County of McLeod, State of Minnesota;
- 4. That the number of the Commissioners of the Authority be not less than five (5) nor more than nine (9), all of whom are to be appointed by the governing body of the County of McLeod. The first Board of Commissioners of the Regional Railroad Authority shall consist of seven (7) members, whose names and addresses are as follows:

- 5. That the registered office of the Authority shall be situated in the City of Hutchinson, McLeod County, Minnesota;
- 6. That neither the State of Minnesota, the municipalities, nor any other political sub-division, is liable for the obligations of the Authority;
- 7. That the Authority shall exercise such authority as provided in Minnesota Statutes §398A.01 398.09 in conducting the business of the Authority as well as any other provisions for conducting business as determined by the governing body adopting this Resolution.

FURTHER, before final adoption of this organizational Resolution, the County of McLeod shall provide for a public Hearing upon notice published in a newspaper of general circulation in the county. The Notice of Hearing shall be mailed to the governing body of each city or town in the county at least thirty (30) days before the Hearing.

Upon being put to vote on the above Resolution, all voted "yes", motion passed.
