

ORDER

WHEREAS, a joint resolution for orderly annexation was adopted by the City of Northfield and the Town of Northfield and duly accepted by the Minnesota Municipal Board; and

WHEREAS, resolutions were received from the City of Northfield and the Town of Northfield indicating their desire that certain property be immediately annexed to the City of Northfield pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 requires that the Minnesota Municipal Board review and comment, but within 30 days approve the annexation of land pursuant to said subdivision; and

WHEREAS, on April 19, 1985, the Minnesota Municipal Board has reviewed and approved the amendment to the joint agreement for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Northfield, Minnesota, the same as if it had

originally been made a part thereof:

The SW 1/4 of the NW 1/4 of Section 5, T111, R19 W, and all that part of the NW 1/4 of the SW 1/4 of Section 5, T111, R19 W, which lies north of the North Dennison Road (County Road 28) except a distance of 28 rods east from the intersection of the North Dennison Road and Spring Creek Road along the centerline of the North Dennison Road, then north 25 rods, then west 28 rods to Spring Creek Road, then south 25 rods to the point of beginning.

IT IS FURTHER ORDERED: That the effective date of this order is April 19, 1985.
