Sufficient petitions having been filed with the Water Resources Board seeking changes in the boundaries of the Lower Minnesota River, Nine Mile Creek, Minnehaha Creek, and Riley-Purgatory-Bluff Creek Watershed Districts; a public hearing having been conducted on the petitions; the report of the administrative law judge having been received; and no written exceptions to the administrative law judge's report pertaining to the boundary of the Riley-Purgatory-Bluff Creek Watershed District having been received; the Water Resources Board having fully considered the record makes the following:

FINDINGS OF FACT

The Findings of Fact contained in the attached report of the administrative law judge are adopted by the Water Resources Board, with the exception of Findings of Fact No. 3 and No. 6. It would serve the purposes of Minnesota Statutes Chapter 112 and the public welfare and public interest to change the boundary of the Nine Mile Creek Watershed District as requested in the petitions.

IT IS THEREFORE ORDERED THAT

The legal boundary of the Nine Mile Creek Watershed District is defined by the following boundary description, which supersedes the original boundary defined in the Water Resources Board's September 30, 1959 Order that established the District, and the Water Resources Board's boundary change Orders dated May 16, 1960 and July 11, 1961:
