FINDINGS OF FACT,
CONCLUSIONS OF LAW,
AND ORDER

On May 13, 1985, the Minnesota Municipal Board received a resolution from the City of Blaine, which requested the detachment of certain property and the City of Lexington, which requested the annexation of the same territory pursuant to Minnesota Statutes 414.061.

After review of the resolutions, the Minnesota Municipal Board hereby makes and files the following Findings of Fact, Conclusions of Law, and Order.

FINDINGS OF FACT

1. That a resolution supporting detachment of certain property was received from the City of Blaine and a resolution supporting annexation of said property was received from the City of Lexington.

2. The resolutions contained all the information required by statute including a description of the territory proposed for detachment and annexation, which is as follows:

3. The area proposed for detachment is situated within the City of Blaine and abuts the municipal boundary of the City of Lexington.

CONCLUSIONS OF LAW

1. The Minnesota Municipal Board duly acquired and now has jurisdiction of the within proceeding.

2. An order should be issued by the Minnesota Municipal Board concurrently detaching and annexing the area described herein.


ORDER
