ORDER REDEFINING Districts Filed on October 3 and THE BOUNDARY OF THE Districts Filed on October 3 and MINNEHAHA CREEK December 4r 1984 (Minnesota Statutes WATERSHED DISTRICT 1984, Section 112.39, Subd. 4)

Sufficient petitions having been filed with the Water Resources Board seeking changes in the boundaries of the Lower Minnesota River, Nine Mile Creek, Minnehaha Creek, and Riley-Purgatory-Bluff Creek Watershed Districts; a public hearing having been conducted on the petitions; the report of the administrative law judge having been received; and one written exception to the administrative law judge's report pertaining to the boundary of the Minnehaha Creek Watershed District having been received; the Water Resources Board having fully considered the record makes the following:

## FINDINGS OF FACT

I. The Findings of Fact contained in the attached report of the administrative law judge are adopted by the Water Resources Board, with the exception of Findings of Fact No. 3 and No. 6.
II. The joint petition dated October 2, 1984 was served by mail on the Auditors of Carver, Dakota, Hennepin, and Scott Counties; and the Commissioner and the Director of the Division of Waters of the Department of Natural Resources.
III. By petition dated November 29, 1984 the Minnehaha Creek Watershed District seeks changes in its boundary in addition to the changes requested in the joint petition dated October 2, 1984. The November 29, 1984 petition was served by mail on the Auditors of Carver and Hennepin Counties; and the Commissioner and the Director of the Division of Waters of the Department of Natural Resources.
IV. On January 7, 1985 the Water Resources Board received the report of the Director of the Division of Waters of the Department of Natural Resources on the petitions.
V. On March 8, 1985 the Water Resources Board received a letter from Jeffrey W. Hedtke, Planning Coordinator for the Carver Soil and Water Conservation District regarding the proposed change in the boundary of the Minnehaha Creek Watershed District in Section 25 of Watertown Township (Township 117 North, Range 25 West) in Carver County. The administrative law judge recommended that the boundary be changed as requested by the petitioners, which, in this section, would exclude the $\mathrm{N} 1 / 2$ of the $\mathrm{NE} 1 / 4$ from the District. Mr. Hedtke pointed out that this would result in two taxing parcels being split by the boundary. He discussed the proposed boundary with the Carver County Zoning Office and they agreed that it would be preferable to change the boundary in Section 25 by excluding the $W 1 / 2$ of the NE $1 / 4$, rather than the $N 1 / 2$ of the NE $1 / 4$ as proposed by the petitioners, to avoid splitting taxing parcels. Exhibit $2 \mathrm{~B}_{\mathrm{r}}$, Sheet 2, shows the hydrologic boundary crossing the NE $1 / 4$ of Section 25 diagonally from the northeast to the southwest. The boundary proposed by Mr. Hedtke would conform to the actual hydrologic boundary equally as well as the boundary proposed in the petitions.
VI. The Water Resources Board first considered the administrative law judge's report and the hearing record at its meeting on March 8, 1985. Legal descriptions were provided for nearly all of the proposed boundary changes, except for the changes proposed to the Minnehaha Creek Watershed District where it adjoins the Bassett Creek Watershed Management Organization in the cities of Minneapolis, Golden Valley, St. Louis Park, and Minnetonka. Legal descriptions for these proposed changes are needed in order for the Water Resources Board to amend the boundary of the District. The Board informed the Bassett Creek Watershed Management Organization on March 13, 1985 that it would include these proposed changes in its boundary change Order, if it received the necessary legal descriptions. The Bassett Creek Watershed Management Organization submitted the required legal descriptions on May 10, 1985.

## CONCLUSIONS OF LAW

I. The Conclusions contained in the attached report of the administrative law judge are adopted by the Water Resources Board.
II. It would serve the purposes of Minnesota Statutes Chapter 112 and the public welfare and public interest to change the boundary of the Minnehaha Creek Watershed District as requested in the petitions, as modified by the recomendation discussed in Finding No. V.

## IT IS THEREFORE ORDERED THAT

I. The legal boundary of the Minnehaha Creek Watershed District is defined by the following boundary description, which supercedes the original boundary defined in the Water Resources Board's March 9, 1967

Order that established the District, and the Water Resources Board's boundary change Orders dated November 5, 1971; March 19, 1979;

December 9, 1981; and June 8, 1984 :

Notice is hereby given that, pursuant to Minn. ## STATEMENT OF ISSUES

Whether the subject watershed districts should be authorized to modify their respective boundaries so as to comport with actual drainage characteristics?

By reason of the foregoing, the undersigned makes the following:

## FINDINGS OF FACT

1. By joint petition dated October 2, 1984 and filed with the Minnesota Water Resources Board on October 3, 1984, the petitioning watershed districts seek changes in their respective boundaries as set forth in the legal descriptions attached hereto.
2. On December 7, 1984, the Chairman of the Water Resources Board issued a Notice of and Order for Hearing scheduling a public hearing for January 8, 1985. A copy of said Notice and Order was mailed to numerous public officials and agencies including the Director of the Division of Waters and private persons. A copy of said Notice and Order was also published in the Eden Prairie News on December 19 and 26, 1984 and in the Carver County Herald on December 19 and 26, 1984.
3. The subject watershed districts share contiguous boundaries in such a manner as to comprise a unified land area in southwestern Hennepin and northern Carver Counties. There is no non-watershed district land encompassed within these boundaries.
4. The existing legal boundaries of the subject watershed districts do not in all instances match the actual drainage divides with the result that in such instances drainage from one watershed district flows into another. The proposed modified boundaries do more accurately comport with actual drainage divides and sound hydrologic principles.
5. All public bodies and municipalities which will be affected by the proposed boundary modifications have been fully informed of the nature of the proposed changes and have either expressly consented thereto or have failed to register any opposition thereto.
6. The proposed boundary changes will result in some lands being added to different watershed districts, and removed from certain other districts, but in no event would any lands not now in any watershed district be included in an existing watershed district.
7. The land which would be removed from one watershed district and added to another is in every instance contiguous to the watershed district into which it would be incorporated.
8. Each and every proposed boundary relocation resulting in land being removed from one district and added to an existing watershed district can be reasibly and properly administered by the existing Board of Managers of the watershed district to which the land is proposed to be added.
9. No material difference in costs and expenses is expected to be levied and assessed against any lands affected by any of the proposed changes in boundaries.

Based upon the foregoing Findings of Fact, the Administrative Law Judge makes the following:

## CONCLUSIONS

1. The Water Resources Board and the Administrative Law Judge have jurisdiction in this matter.
2. All relevant, substantive and procedural requirements of law and rule have been fulfilled.
3. Sound hydrological principles and management require a granting of the request to modify the boundaries of the subject watershed districts.

Based upon the foregoing Conclusions, the undersigned makes the following:

## RECOMMENDATION

IT IS HEREBY RECOMMENDED that the Minnesota Resources Board grant the joint petition of the Lower Minnesota River, Minnehaha Creek, Nine Mile Creek, and Riley-purgatory-Bluff Creek Watershed Districts in such a manner as to comport with the legal descriptions set forth in the Appendices attached hereto.
