The annexation is final upon the date the ordinance is approved by the Board, which is the date of this letter.



AN ORDINANCE OF THE CITY OF NORTH MANKATO, MINNESOTA
AMENDING ORDINANCE NUMBER 34, THIRD SERIES CONCERNING THE LEGAL
DESCRIPTION OF LAND ANNEXED BY THE CITY AND IDENTIFIED AS THE
SAUCIER ADDITION.

THE CITY COUNCIL OF THE CITY OF NORTH MANKATO, MINNESOTA
ORDAINS:

Section 1. Ordinance Number 34, Third Series, is hereby
amended by changing the legal description of that certain pro-
perty annexed to the City of North Mankato known as the Saucier
Addition:

Parcel #1. SW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 1, Twp. 108N, Range
27W lying Northwesterly of Trunk Highway
14 right-of-way in said section. Except
the north 300 feet of the East 420 feet;
Also except the west 367.81 feet of the
north 592.15 feet of said Section 1.

Parcel #2. SE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 2, Township 108 N,
Range 27W, except Valley View
Subdivision 2 and Valley View
Subdivision 4.


Section 2. Such amended legal description constitutes the
same land which was annexed by Ordinance Number 34, Third Series.

Section 3. After adoption, signing and attestation, this
Ordinance shall be published once in the official newspaper of
the City and shall be in effect on and after the date following
such publication and the date that this annexation is approved by
the Municipal Board of the State of Minnesota.
