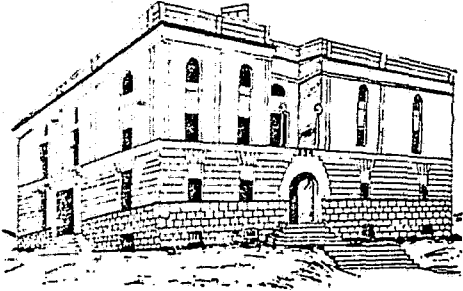

All that part of the Southeast Quarter (SE $\frac{1}{4}$ ) of said Section 14 which lies south and west of Minnesota State Highway 21 and all that part of the Southwest Quarter (SW $\frac{1}{4}$ ) excluding the Southwest Quarter of the Southwest Quarter (SW $\frac{1}{4}$  of SW $\frac{1}{4}$ ) of Section 14, Township 110 North, Range 21, west of the Fifth Principal Meridian, Rice County, Minnesota, containing 207 acres more or less; and also,

All that part of the north half of the Northeast quarter (N $\frac{1}{2}$  of NE $\frac{1}{4}$ ) of Section 23 and all that part of the Southeast quarter of the Northeast Quarter (SE $\frac{1}{4}$  of NE $\frac{1}{4}$ ) of said Section 23 and all that part of the Northeast Quarter of the Southeast Quarter (NE $\frac{1}{4}$  of SE $\frac{1}{4}$ ) of said Section 23 that lie north of southeasterly right-of-way line of Interstate 35, all in Township 110 North, Range 21 West, Rice County, Minnesota and containing 132 acres more or less; and also,

All that part of the Northwest quarter (NW $\frac{1}{4}$ ) of Section 24, Township 110 North, Range 21 West, Rice County, Minnesota that lies north of the Interstate 35 and Minnesota State Highway 21 intersection and southwesterly of the Shieldsville Road and all that part of the above said intersection of Interstate 35 and Minnesota State Highway 21 located in the Southwest quarter of the Northwest Quarter (SW $\frac{1}{4}$  of NW $\frac{1}{4}$ ) of Section 24, Township 110 North, Range 21 West, Rice County, Minnesota, containing 12.1 acres more or less.

All that part of the Northwest quarter of the Southeast Quarter (NW $\frac{1}{4}$  of SE $\frac{1}{4}$ ) of Section 26, Township 110 North, Range 21 West of the Fifth Principal Meridian, lying easterly of Interstate 35 bounded by the City of Faribault, Rice County, Minnesota, corporate limits to the north and east and comprising of 3.9 acres more or less.
