

ORDINANCE NO. 3

AN ORDINANCE EXTENDING THE CORPORATE LIMITS
OF THE CITY OF DETROIT LAKES, MINNESOTA
TO INCLUDE CERTAIN UNINCORPORATED PLATTED LAND
(UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA)
ABUTTING UPON THE CITY LIMITS

WHEREAS, a certain petition dated February 4, 1985, requesting annexation of the territory hereinafter described was duly presented to the City Council on the 5th day of February 1985; and

WHEREAS, the petition was signed by eight (8) owners, constituting a majority but not all of a total number of fourteen (14) owners; and

WHEREAS, no objections to the annexation have been received from the town board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, a hearing was duly held by the governing body of the City of Detroit Lakes, Minnesota, on the proposed annexation after at least 30 days mailed notice; and

WHEREAS, the land described in the petition abuts upon the City limits at the south boundary thereof.

The Council of the City of Detroit Lakes, Minnesota, does ordain:

Section 1. The City Council hereby determines (1) that the territory described herein abuts upon the City limits and is urban or suburban in character; and (2) that none of the territory is not included within the limits of any city.

Section 2. Territory Annexed. The corporate limits of the City are hereby extended to include the platted (unplatted) land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:


All of Government Lot 1, East of the centerline of C.S.A.H. No. 114 in Section 10, T138N, R41W, area includes the Sunset Park Addition, 40.3 acres.

Section 3. Filing. The City Administrator is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Board, the Secretary of State, the Town Clerk, and the County Auditor.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3, and approval of the ordinance by the Minnesota Municipal Board.
