ORDINANCE NO. 239
2nd Series

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF ALEXANDRIA TO INCLUDE CERTAIN UNINCORPORATED PLATTED LAND ABUTTING UPON THE CITY LIMITS

WHEREAS, a certain petition dated June 3, 1985, requesting annexation of certain land described was duly presented to the Alexandria City Council on June 10, 1985; and

WHEREAS, the petition was signed by the sole affected property owner; and

WHEREAS, no objections to the annexation have been received from the Alexandria Town Board or the Douglas County Board of Commissioners after at least ninety (90) days mailed notice; and

WHEREAS, the land described in the petition abuts upon the City limits at the northern boundry thereof;

NOW THEREFORE BE IT ORDAINED by the City Council of the City of Alexandria, Minnesota that:

SECTION I. The Alexandria City Council hereby determines that the territory described herein abuts upon the City limits and is urban or suburban in character, and that none of the territory is now included within the City limits of any City.

SECTION II. The corporate limits of the City are hereby extended to include the platted land described as follows and the same is hereby annexed to and included within the City as effectually as if it has originally been a part thereof. The legal description of the property in questions is the Southwest 2.47 Acres of Lot E, Auditor's Subdivision of the West $\frac{1}{2}$, Northwest $\frac{1}{4}$ of Section 17, Township 128, Range 37 (Parcel Number 03-1437-000).

SECTION III. The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Board, the Secretary of State, the Alexandria Town Clerk, and the Douglas County Auditor.

SECTION IV. The annexed property herein described shall be zoned "R-1" Single Family Residential.

SECTION V. This Ordinance shall become effective as of January 1, 1986.
