ORDINANCE NO. 34, SECOND SERIES

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF BEMIDJI TO INCLUDE CERTAIN UNINCORPORATED TERRITORY

WHEREAS, certain territory described below is not presently included within any other municipality and does not abut upon the limits of any other municipality, and

WHEREAS, the owners of this territory have petitioned the City for annexation by ordinance pursuant to Minnesota Statutes 414.033, and

WHEREAS, said property abuts upon the limits of the City of Bemidji, is platted in part and unplatted, and does not exceed 200 acres in area in part, and

SECTION 1. TERRITORY ANNEXED.

The corporate limits of the City of Bemidji, Minnesota, are hereby extended to include the unplatted territory described as follows:

> The South 30 feet of the West 417 feet of the East 450 feet of the SE 1/4 of Section 32, Township 147 North, Range 33 West; the South 33 feet of the SE 1/4 of Section 32, Township 147 North, Range 33 West except the East 450 feet thereof and the South 33 feet of the East 500.01 feet of the SE 1/4 SW 1/4 of Section 32, Township 147 North, Range 33 West.

SECTION 2. FILING.

The City Clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of Beltrami County, and the Minnesota Municipal Commission.

SECTION 3. EFFECTIVE DATE OF ANNEXATION.

This ordinance shall take effect upon its passage and publication and the filing of certified copies as directed in Section 2.
