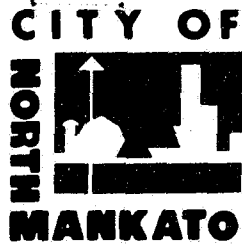

ORDINANCE NO. 61
Series No. Third

AN ORDINANCE OF THE CITY OF NORTH MANKATO, MINNESOTA
DECLARING CERTAIN LAND TO BE ANNEXED TO SUCH CITY, IDENTIFIED AS
PARTS OF FORSBERGS SUBDIVISION AND ADJACENT LANDS.

THE CITY COUNCIL OF THE CITY OF NORTH MANKATO, MINNESOTA
ORDAINS:

Section 1. The following tract of unincorporated property
abuts upon the municipal limits of the City of North Mankato,
Minnesota.

Section 2. The legal description of said land is shown upon
Exhibit A, attached hereto and the same is incorporated herein by
reference.

Section 3. Such land is now or is about to become urban or
suburban in character.


Section 4. Part of the land is platted and part of the land
is unplatted, but does not exceed 200 acres.

Section 5. One hundred percent (100%) of the ownership
interest in such land has petitioned the North Mankato City
Council to have such land included within such city's municipal
limits.

Section 6. Such land is hereby annexed to the City of North
Mankato, Minnesota and is declared to be included within its
municipal limits.


Section 7. After adoption, signing and attestation, this
ordinance shall be published once in the official newspaper of
the City and shall be in effect on and after the day following
such publication and the date this ordinance is approved by the
Municipal Board of the State of Minnesota.

CONSENT TO ANNEXATION PROCEDURE

TO: State Municipal Board

Re: Annexation of Auditor's Plat No. 1 and Forest Heights and Forsberg's Subdivision.

1. The Belgrade Township Board acknowledges receipt of an Ordinance of Annexation as well as the petition for annexation concerning land which is described upon Exhibit A attached to such ordinance.
2. It is understood that the Township Board has the right to submit written objections to such annexation to the Municipal Board and the City of North Mankato within 90 days from the date of the service of the notice.
3. The Belgrade Township Board hereby consents to allowing the annexation procedure to proceed without further delay.
4. Therefore, the Belgrade Township Board waives its right to object to said procedure and waives the 90 day waiting period.

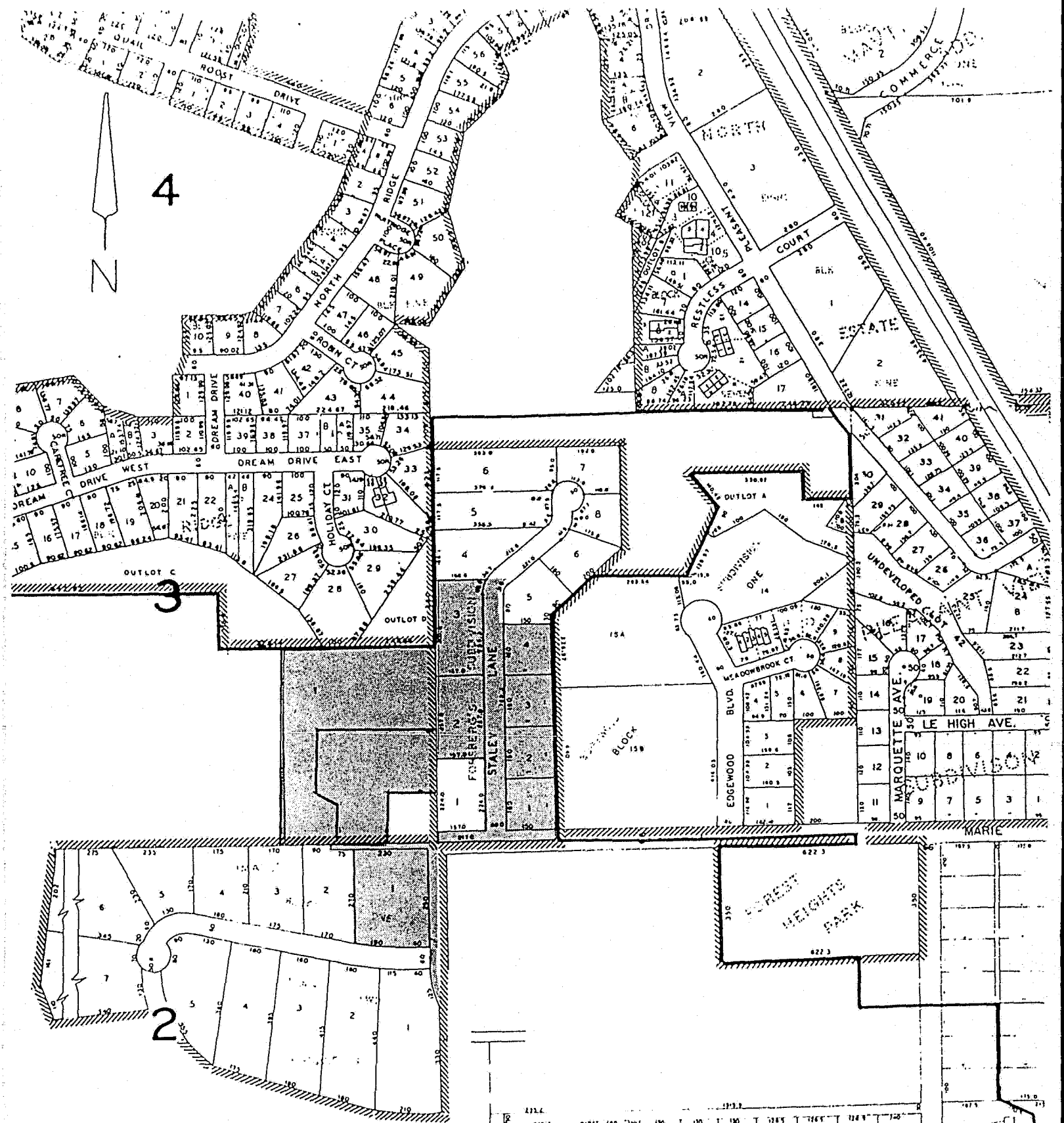
