Due to a typographical error in a portion of the legal description of certain properties recently annexed into the City of North Mankato, we request that you adjust your records accordingly. Annexation of parcels in question was finalized by the Municipal Board on November 15, 1985, and was identified as Docket No. 42-70. 



ORDINANCE NO. 62 Series No. Third

AN ORDINANCE OF THE CITY OF NORTH MANKATO, MINNESOTA DECLARING CERTAIN LAND TO BE ANNEXED TO SUCH CITY, IDENTIFIED AS AUDITOR'S PLAT NO. 1 AND FOREST HEIGHTS.

THE CITY COUNCIL OF THE CITY OF NORTH MANKATO, MINNESOTA ORDAINS:

Section 1. The following tract of unincorporated property abuts upon the municipal limits of the City of North Mankato, Minnesota.

Section 2. The legal description of said land is shown upon Exhibit A, attached hereto and the same is incorporated herein by reference.

Section 3. Such land is now or is about to become urban or suburban in character.

Section 4. The land proposed for annexation is platted.

Section 5. One hundred percent (100%) of the ownership interest in such land has petitioned the North Mankato City Council to have such land included within such city's municipal limits.

Section 6. Such land is hereby annexed to the City of North Mankato, Minnesota and is declared to be included within its municipal limits.

Section 7. After adoption, signing and attestation, this ordinance shall be published once in the official newspaper of the City and shall be in effect on and after the day following such publication and the date this ordinance is approved by the Municipal Board of the State of Minnesota.


