AN ORDINANCE CORRECTING CHISAGO CI-TY ORDINANCE NO. 134 THAT EXTENDED THE CORPORATE LIMITS OF THE CITY OF CHISAGO CITY TO INCLUDE CERTAIN UNIN-CORPORATED TERRITORY BORDERED BY LAND WITHIN THE CITY LIMITS AND ABUT-TING THEREON.

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, or borough; and WHEREAS, 60% or more of the perimeter of this territory is bordered by lands already included within the corporate limits of the city and is deem-

ed to be urban or suburban in character; The City Council of Chisago City ordains Section 1. Territory Annexed. Chisago City or-dinance number 134 that extended the corporate dinance number 134 that extended the corporate limits of the City of Chisago City is hereby amended to correct the description of the property outlined in ordinance number 134. The property description below is for the same property as the property described in the original ordinance. The corporate limits of the City of Chisago City, Minnesota, are hereby extended to include the platted territory described as follows, 60% or more of the perimeter of which territory is bordered by territory already included within the city limits:

All of Maple Beach Subdivision in
Chisago Villas Addition located in the South % Section 7 and the North % Section 18, T33N R20W; that part of lot 51 Chisago Villas Addition not already within the City. That part of Lot 52 Chisago Villas Addition described as follows, the north 76.4' lying Westerly of the East 428' of said lot lying Westerly of the West R/W of Kent Ct. and it's Northerly extension.

Section 2. Filing. The city clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the county. ty in which the property is located, the Town Clerk of the affected township and the Minnesota Municipal Board.

Section 3. Effective date of annexation. This ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 2 and approval by the Minnesota Municipal
