



ORDER

WHEREAS, a joint resolution for orderly annexation was adopted by the City of Cass Lake and the Town of Pike Bay and duly accepted by the Minnesota Municipal Board; and

WHEREAS, a resolution was received from the City of Cass Lake and the Town of Pike Bay indicating their desire that certain property be immediately annexed to the City of Cass Lake pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 requires that the Minnesota Municipal Board review and comment, but within 30 days approve the annexation of land pursuant to said subdivision; and

WHEREAS, on June 7, 1985, the Minnesota Municipal Board has reviewed and approved the joint agreement for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Cass Lake, Minnesota, the same as if it had originally been make a part thereof:


East One-half of Lot 11, Auditor's Plat Number 3; the East 75 feet of the West One-half of Lot 11, Auditor's Plat Number 3; the West 25

feet of Lot 11, Auditor's Plat Number 3; and the East 25 feet of Lot 12, Auditor's Plat Number 3, all in Cass County, Minnesota.

IT IS FURTHER ORDERED: That the effective date of this order is June 7, 1985.
