It was moved by Wabner, seconded by Collins, to declare John A. Krough elected Second Ward Council Member for a two year term; the motion carried 7-0.


It was moved by Collins, seconded by Krough, to declare Judy Kozan elected Third Ward Council Member for a two year term; the motion carried 7-0.
