WHEREAS: There is increasing use of household and industrial chemicals to perform labor-saving and time-saving tasks and of medicine to provide health giving and life sustaining benefits: and

These products, when not used as intended or directed, may be hazardous to adults and

children, who, from infancy to five years of age, are the more frequent ingestors of poisonous or potentially poisonous substances; and

WHEREAS: The lives of thousands of Minnesotans are threatened each year by the accidental or intentional ingestion of or contact with poisonous substances; and

WHEREAS:

Our state government agencies have been working for years with their local and federal counterparts and other statewide organizations in programs to inform our citizens about WHEREAS: the potential of these hazardous substances when not used as directed; and
