## RUDY PERPICH

*Governor of the State of Minnesota*

TO ALL PEACE OFFICERS, STATE OF MINNESOTA

WHEREAS,

1. The Governor of the State of North Carolina issued his requisition warrant for the arrest of LARRY DON AMES on October 10, 1985;
2. The Honorable Rudy Perpich, Governor of the State of Minnesota, issued his rendition warrant for the return of LARRY DON AMES on October 25, 1985;
3. The Honorable Rudy Perpich convened a governor's hearing on this matter on December 1985; and
4. Following consideration of evidence presented at the hearing, Governor Perpich has declined to reissue his rendition warrant for the return of LARRY DON AMES to the State of North Carolina; and
5. Governor Perpich will not now or at any time in the future issue his rendition warrant in this matter unless LARRY DON AMES commits any new offense in this state punishable by incarceration;

IT IS ORDERED:

That I, Rudy Perpich, Governor of the State of Minnesota, order all peace officers of the State of Minnesota not to arrest or hold LARRY DON AMES on the North Carolina fugitive warrant dated June 18, 1973 or the requisition warrant dated October 10, 1985 unless:

LARRY DON AMES commits any new offense in the State of Minnesota punishable by incarceration.
